- Signal Word: Danger
- Hazard phrases
  - H225 - Highly flammable liquid and vapour.
  - H319 - Causes serious eye irritation.
  - H336 - May cause drowsiness or dizziness.
- Precautionary Phrases
  - P210 - Keep away from heat/sparks/open flames/hot surfaces. – No smoking.
  - P233 - Keep container tightly closed.
  - P243 - Take precautionary measures against static discharge.
  - P370+P378 - In case of fire: Use Water spray, Alcohol resistant foam, Powder or Carbon Dioxide for extinction.

## 4.1 Description of first aid measures

- P303+P361+P353 - IF ON SKIN (or hair): Remove/Take off immediately all contaminated clothing. Rinse skin with water/shower.
- P305+P351+P338 - IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

## 4.2 Most important symptoms and effects, both acute and delayed

- Mildly irritating to respiratory system
- In cases of severe exposure, dizziness, confusion, headache or stupor may develop

## 4.3 Indication of any immediate medical attention and special treatment needed

- P301+P310 - IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician.
  - P101 - If medical advice is needed, have product container or label at hand.
  - If substance has got into eyes, immediately wash out with plenty of water
  - Seek medical attention if irritation persists
  - P331 - Do NOT induce vomiting.
  - P310 - Immediately call a POISON CENTER or doctor/physician.

**SECTION 5 Fire-fighting measures (....)**

- Vapours may travel considerable distances to a source of ignition and flashback
- May give off noxious and toxic fumes in a fire
- Smoke from fires is irritating. Take precautions to protect personnel from exposure

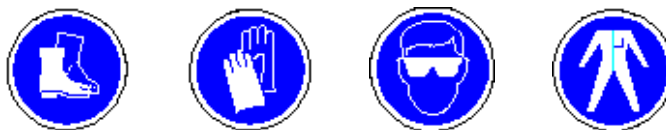
